Any elk harvests must be reported to an AOO Harvest Monitor, your ANR or community designate, or the AOO Consultation Office within 24 hours. Algonquin harvesters who are not successful in harvesting an animal during the AOO harvest season are still encouraged to report harvesting effort and observations through a harvest questionnaire. All information gathered will help inform future harvest planning. Questionnaires can be mailed or dropped off at community offices or the AOO Consultation Office (address below). Please note, all harvests must be reported within 24 hours, but additional harvest effort and observation information is welcome through mailed hard copy.
